Carnarvon Primary School	If adequate funding, consideration will be given to additional set of zig-zag lines.
Restricted parking on Cherry Street/ Church Street.	On-going subject to consultation process.
Network Rail - Bridge	Planning application received and B.T.C. approved sale of land required for bridge July 2014. R.B.C. granted planning permission May 2015.
Bingham Police Station Site	Awaiting feedback from police officials following previous meeting to consider temporary parking etc.
Bingham Signal Box Sign	Network Rail Disposal Form has been signed by Clerk confirming B.T.C. will be presented with the name-board.
